## **Operational Scope**

Our operations can be broadly classified in terms of components, semi-finished and finished products relevant to several key economic sectors as outlined below.

### *1) Building, Construction & Real Estate*

- a) Galvanised pipes and wire mesh modules for fence construction and security/automated access (gate) systems.
- b) Galvanised steel door and curtain wall (cladding) frames
- c) Integrated steel window/burglar bar units.
- d) Pressed steel sanitary wares.
- e) Lighting systems incorporating LED technology.
- f) Metal furniture.
- g) Fibre glass sanitary wares including swimming pool baths.

### *2) Energy (generation, transmission and distribution) infrastructure*

- a) Factory components of Engineering, Procurement, Construction, Operations & Maintenance (EPCOM) contracts for downstream micro gas-power projects (industrial hubs, co-located processing centers, housing estates and new cities.)
- b) Factory components of EPCOM for electricity transmission infrastructure (towers, transmission & distribution sub-stations)
- c) Production of insulation systems for power distribution.
- d) Production of boxes and sound proofing enclosures for feeder pillars, transformers and stand-by generators.
- e) Manufacture of galvanised steel poles for distribution and street-lighting.
- f) Factory components for small hydro generating systems

### *3) Agro-Industrial infrastructure*

- a) Laboratory and measuring/testing apparatus production.
- b) Pressure pipes and vessels as components in industrial systems (heating, cooling, drying, etc.) in manufacturing and agro-processing
- c) Production of frames for photovoltaic module construction.
- d) Agricultural production infrastructure (irrigation systems, animal production systems, green houses etc.)

### *4) Transportation Infrastructure*

- a) Factory components, steel formworks for bridge pilings, large beams, and associated road furniture construction. (Road)
- b) Production of rail tracks and other rail system furniture. (Rail)
- c) Factory Components of commercial and leisure boat construction. (Marine)
- d) Factory components of EPCOM contracts for steel-based aerodromes. (Aviation)
